TERMS OF SETTLEMENT

Whereas the claimant brought this suit claiming against the defendant as follows:

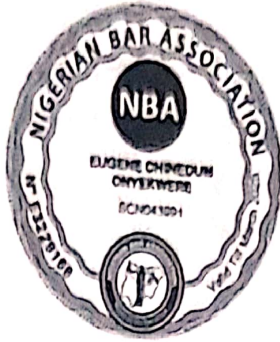
1. The sum of Five Hundred and Forty – Two Thousand, Three Hundred Naira (₦542,300.00) being the cost of fabrics bought on credit on the 29th January, 2023.
2. Ten Percent (10%) interest on the unpaid debt.
3. Cost of litigation of One Hundred and twenty Thousand Naira (₦120,000.00).

Wherefore and pursuant to the provisions of Article 10 of the Small Claims Court Practice Directions, 2022, the claimant and the defendant hereby agree to resolve the matter on the following terms:

1. That the defendant herein admits liability of the sum of Five Hundred and Forty - Two Thousand, Three Hundred Naira (₦542,300.00).
2. The Defendant concedes to pay the sum of Fifty Thousand Naira (₦50,000.00) and Seventy Thousand Naira (₦70,000.00) as interest and cost of litigation respectively with regard to the claimant's claim herein.
3. That the defendant shall pay the total sum of Six Hundred and Sixty-Two Thousand, Three Hundred Naira (₦662,300.00) in five consecutive equal instalments of One Hundred and thirty - two Thousand, four hundred and sixty Naira (₦132,460.00) with effect from 15th August, 2024.
4. That the instalmental payments shall be made to the claimant's counsel's Access Bank Account No: 0018587766.
5. That if the defendant defaults in payment, the Claimant reserves the right to enforce the Judgment accordingly.
6. That the Court should enter a consent judgment on the strength of this terms of settlement.

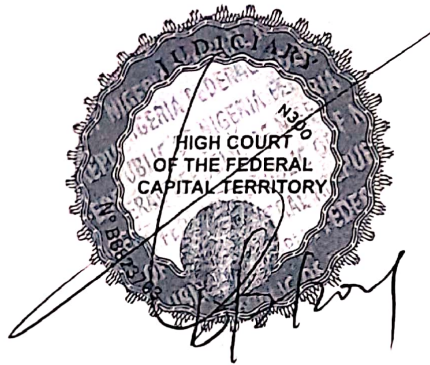
