RULING

The Judgment Creditor in this case filed a motion ex parte under the Sheriff and Civil Process Act to enforce the judgment delivered against the judgment debtors on 18 different banks; one of which is first bank Nigeria PLC (the 3rd Garnishee).

All other Garnishees served have been discharged by Hon. Justice Olatoyibo (now retired), save for the 3rd Garnishee.

The 3rd Garnishee, filed an 8-paragraph affidavit to show cause on the 25th of April 2019, and a further affidavit was also filed on the 8th day of May 2019 by the 3rd Garnishee and served on the Judgment Creditor. From the facts stated therein, search was conducted and from the search, both the 1st and 2nd Judgment Debtors do not maintain any account relationship with the bank and urged the Court to discharge the garnishee.

Counsel for the Judgment Creditor, Emmanuel Akumah, Esq., informed this Court to discharge the 3rd Garnishee (First Bank of Nigeria Limited).

On the strength of the affidavit evidence and further affidavit, and upon hearing Counsel to the Judgment/Creditor, the 3rd Garnishee having disclosed that Judgment Debtors have no account with First Bank Nigeria Limited, the 3rd Garnishee is hereby discharged and the Order Nisi against the 3rd Garnishee, set aside
