## RULING

The Judgment Creditor in this case filed a motion ex parte under the Sheriff and Civil Process Act to enforce the judgment delivered against the judgment debtors on 19 different banks with Affidavit attached, deposed to by Seidu David and after hearing D. A. Seidu of learned counsel to Judgment Creditor / Applicant praying the Honourable Court for the following Orders;

1. An order attaching the sum of N5,239,000.00 (Five Million Two Hundred and Thirty Nine Thousand Naira) only being the total Judgment sum in the Suit No: CV/1869 due to the Judgment Creditor/Applicant and standing to the credit of the Judgment Debtor in her account with the Garnishees.
2. An order nisi directing the 1<sup>st</sup> – 19<sup>th</sup> Garnishees to appear before this Honourable Court to show cause why it should not be made to pay over the Judgment Creditor, the said sum of N5,239,000.00 (Five Million Two Hundred and Thirty Nine Thousand Naira) only being the total Judgment sum in the Judgment which was delivered on 30<sup>th</sup> day of September, 2020 only in satisfaction of the judgment debt in Suit No: CV/1869/19.
3. Any further order(s) as this Honourable Court may deem fit to make in the circumstances of this case.

Upon a careful consideration of the Motion Exparte, it is hereby ordered as follows:

1. A Garnishee Order Nisi is hereby granted, attaching the sum of N5,239,000.00 (Five Million Two Hundred and Thirty Nine Thousand Naira) only being the total Judgment sum in the Suit

- No: CV/1869 due to the Judgment Creditor/Applicant and standing to the credit of the Judgment Debtor in her account with the Garnishees.
2. The 1<sup>st</sup> – 19<sup>th</sup> Garnishees is hereby directed to appear before this Honourable Court to show cause why it should not be made to pay over to the Judgment Creditor, the said sum of N5,239,000.00 (Five Million Two Hundred and Thirty Nine Thousand Naira) only being the total Judgment sum in the Judgment which was delivered on 30<sup>th</sup> day of September, 2020 only in satisfaction of the judgment debt in Suit No: CV/1869/19.
  3. The Garnishees shall within 15days upon service of this Order on them show cause by Affidavit why the Order Nisi should not be made absolute on them.
  4. This order and like processes to be served on all Garnishees and Judgment Debtor as prescribed by the Sheriff and Civil Processes Act.
  5. Case is adjourned to 5<sup>th</sup> of November, 2020 for cause to be shown by the Garnishees.
