Parties have settled their grievances and in compliance with this Honourable Court's

directive, we have filed our Terms of Settlement and with the Court's convenience, we

seek to adopt same.

The Terms of Settlement is dated 23/3/2021 and filed today, 24/3/2021. We humbly

pray this Honourable Court to adopt same as Judgment in this case.

Counsel for the Defendant: The Terms of Settlement as adopted by my learned

Colleague is the true reflection of our agreement. We adopt same as our Judgment.

COURT: By a Writ of Summon brought under the Undefended ListProcedure dated

28/1/2021 and filed on 29/01/2021, the Claimant claimed from the Defendant the

following:-

- (a) An Order directing the Defendants to pay the sum of ₩14,000,000.00 being the amount owed as rent by the Claimant.
- (b) The cost of the suit.

Midway into the hearing of this suit, parties indicated their desire to settle out of Court.

They were, accordingly encouraged by the Court to file the Terms of Settlement. The

Terms of Settlement filed by the parties is reproduced verbatim hereunder:-

## TERMS OF SETTLEMENT

## **WHEREAS**

- A. The Claimant brought this suit against the Defendant asking for the following reliefs:-
  - (a) An Order directing the Defendant to pay the sum of ₩14,000,000.00 being the amount owed as rent by the Claimant; and
  - (b) The cost of the suit.
  - (c) The Defendant, before the 18<sup>th</sup> day of March, 2021 fixed for hearing of this suit, paid the said sum of ₩14,000,000.00 to the Claimant as final settlement of the Claimant's claim.

## NOW THEREFORE THESE TERMS OF SETTLEMENT WITNESSES AS FOLLOWS:-

- B. The dispute between the parties has been fully settled by payment of the sum aforesaid.
  - The parties have agreed that ₩14,000,000.00 paid by the Defendant has settled the Claimant's reliefs.

2. This Terms of Settlement be filed in Court and adopted as full and final

settlement of all the issues in controversy between the parties in this suit.
