CONSENT JUDGMENT

- 1. The sum of Fourteen Million Naira (N14,000,000.00) only paid to the Defendants for money had and received.
- 2. 10% post judgment interest on the judgment sum.

I have read and considered the terms of settlement as reproduced below jointly executed by the parties which was presented to the Honourable Court for adoption as follows:

- 1. That the 1st Defendant hereby accepts liability on behalf of all the defendants in respect of the debt and claim of N14, 000,000.00 (Fourteen Million Naira) in this suit.
- 2. That the 2nd to 4th defendants are hereby exonerated from any liability whatsoever in respect of the within mentioned amount of money.
- 3. That the 1st defendant shall take full responsibility and liquidate the within mentioned sums of money.
- 4. That the 1st defendant shall pay the within mentioned sums of money on a pro-rated basis and in four separate installments as follows:
 - a). N4, 000,000- on or before 30th September 2021
 - b) N4, 000,000- on or before 31st December 2021.
 - c) N4, 000,000- on or before 31st March 2022
 - d) N 2,000,000- on or before 30th June 2022
- 5. That the Claimant shall make an account available for this purpose.

6. That this shall be a total and final settlement of any claim whatsoever from the Claimant.

7. in witness of which the parties have executed this term of settlement.

In view of the forgoing, terms of settlement dated the 2nd day of July and filed on the 5th day of July 2021 is hereby adjudged as Judgment of the Court.
