CONSENT JUDGMENT

The Claimant commenced this suit via a Writ of Summons filed on the 10th day of October 2022, praying the Court for the following reliefs:

- a) An order of the Court directing the defendant to pay forthwith, the sum of \$20,000.00 (Twenty Thousand United State Dollars) to the Claimant being, the sum he owes the Claimant.
- b) An order of the court directing the defendant to pay 10% interest on the judgment per month from the date of judgment till the final liquidation of the judgment sum.
- c) N2,000,000.00 as judgment cost.

The parties have thereafter filed terms of settlement dated the 24th day of May, 2023 and filed 6th day of June, 2023, signed by the Claimant and the Defendant as well as their respective Counsel; Chinedu G. Udora, Counsel for the Claimant and Paul Odeh Esq., Counsel for the Defendant. Both Counsel urged the Court to enter the terms so file as judgment in this Court and this Court hereby order as follows:

1. That the Defendant shall pay the Claimant the sum of \$20,000.00 (Twenty Thousand United State of America Dollars each) in four instalments of \$5,000.00 (Five Thousand United State of America Dollars each) first of such payments shall be on or before 31st day of May, 2023 and the second payment shall be made on or before the 30th June, 2023, third payment on or before the end of July, and final payment shall be on or before the end of August.
2. That there shall be no any form of interest to be paid on the said \$20,000.00 (Twenty Thousand United State of America Dollars)
3. That Parties shall bear their respective cost of filing.
4. That Parties agree that this Terms of Settlement (upon execution thereof) shall be entered as the judgement of the Court in relation to

the Parties before it and shall operate as a waiver of any present or future action of whatsoever nature in respect of the subject matter of this Suit or any other claims whatsoever between the Claimant and the Defendant unless the Defendant defaults in making the payments as have agreed in the Terms stated in Paragraph 1 above.
