## JUDGMENT

The Terms of Settlement dated the 6<sup>th</sup> day of July 2023 is hereby made Judgment of this Court as follows:

 The Claimant hereby relinquishes her rights and claims to approximately 121sqm<sup>2</sup> of land, which is alleged to have been encroached upon by the 1<sup>st</sup> Defendant. This land is in relation to the plot measuring about 400 square meters situate at Plot No. 215, Cadastral Zone, Karu Village Extension II Layout, Abuja.

- 2. The 1<sup>st</sup> Defendant shall immediately pay the Claimant the sum of ¥300,000.00 (Three Hundred Thousand Naira) only. This amount represents compensation for the expenses incurred by the Claimant in fencing the aforementioned 121sqm<sup>2</sup> of land, which was allegedly encroached upon by the 1<sup>st</sup> Defendant.
- 3. The Claimant concedes that the said 121sqm<sup>2</sup> of land rightfully belongs to the 1<sup>st</sup> Defendant and is part of the 1<sup>st</sup> Defendant's plot measuring approximately 1000sqm<sup>2</sup>, situate at Plot 493, Jikwoyi Extension II Layout, Abuja.
- 4. The Claimant hereby waives and abandons any other claims she has against the 1<sup>st</sup> Defendant regarding the plot of land measuring about 400 square meters

situate at Plot No. 215, Cadastral Zone, Karu Village Extension II Layout, Abuja.

- 5. The 1<sup>st</sup> Defendant hereby waive and abandon any other claims he has against the Claimant regarding the plot of land measuring approximately 1000 sqm<sup>2</sup> located at Plot 493, Jikwoyi Extension II Layout, Abuja. The Claimant hereby acknowledges the 1<sup>st</sup> Defendant as the beneficial owner of the aforementioned plot.
- 6. Each party shall bear their own cost in respect of this suit.
